## AerCap Holdings N.V. Revolving Credit Facility Update

Dublin – March 13, 2020 - AerCap Holdings N.V. ("AerCap") (NYSE: AER) today announced that AerCap Holdings N.V. and certain of its subsidiaries ("We," or "AerCap") are party to a \$4.0 billion unsecured revolving credit facility with a syndicate of financial institutions that matures in February 2024.

On March 12, 2020, we provided a borrowing notice to the lenders with respect to the remaining available amount under this facility.

Aengus Kelly, CEO of AerCap, said, "We have decided to take this action as a precautionary measure, given recent market volatility. As I said earlier this week at an industry conference, AerCap continues to maintain a strong liquidity and financial position, with \$28.2 billion of unencumbered assets and \$8.2 billion of available liquidity as of December 31, 2019."

AerCap is the global leader in aircraft leasing with 1,334 aircraft owned, managed or on order and \$43.7 billion of total assets as of December 31, 2019. AerCap has one of the most attractive order books in the industry. AerCap serves approximately 200 customers in approximately 80 countries with comprehensive fleet solutions. AerCap is listed on the New York Stock Exchange (AER) and has its headquarters in Dublin with offices in Shannon, Los Angeles, Singapore, Amsterdam, Shanghai, Abu Dhabi, Seattle and Toulouse.
